## FEES

Application Fee (New Students).....	\$75 / student
New Family Registration Fee .....	\$200 / family
Homeschool Registration Fee.....	\$200 / family

\*\* Registration fees are non-refundable unless CKA does not accept the family's application or enrollment is contingent upon receiving a financial grant.

## TUITION & FEES

- Kindergarten (Half Day)..... \$4,190

- 2 Student (Grade 1-9)..... \$11,730
- Each Additional Child..... \$4,630
- 5<sup>th</sup> and 6<sup>th</sup> Grade Outdoor Ed Fee..... \$200
- Junior High Sports Participation Fee..... \$55

## TUITION PRORATION POLICY

No tuition refunds will be given for vacation, absence or other non-withdrawal situations.

LATE ENTRY: Students entering after day 10 of the school's calendar year will have a pro-rated tuition rate.

WITHDRAWAL: For those paying monthly, no refund will be given in the billing month of withdrawal. For those who have paid the entire amount of tuition, the following shows the amount refundable:

This applies at any time during the withdrawal month.

## PAYMENT OPTIONS

**A - Pay Ahead**

3% discount of total tuition if paid by August 15, 2008.

**B - 10 Month Plan**

10 monthly payments due the first of each month, August - May.

**C – 11 or 12 Month Payment Plans**

Options beginning in June or July are available. Contact the school office for information.

## FINANCIAL POLICY

Parents will be given a payment booklet for making tuition payments. A billing statement will be sent only in the event an account is in arrears. Payments are due on the 1st of each month but grace is given until the 10th. If payment has not been received by the 10th, there is a late fee (see above). No accounts are to be beyond 30 days delinquent. Parents may be asked to withdraw students for non-payment.

## FINANCIAL GRANTS

Some financial grants are available for eligible families. After you have paid the registration fee, you may request a Financial Grant Application in the school office. FINANCIAL GRANT APPLICATIONS MUST BE TURNED IN TO THE CKA OFFICE BY JUNE 1 IN ORDER TO BE CONSIDERED. If enrollment is contingent upon financial grants, the applicant may request that their registration fee be refunded should a grant not be available. The maximum aid available per family is 50%.

## WITHHOLDING OF RECORDS

**All accounts, both tuition and non-tuition, must be cleared before the last day of school or a bar will be placed on student records.**

Accounts must be cleared before enrollment for the next school year can be accepted.

If the account remains delinquent after the student withdraws, the account will be reported to a credit bureau.
